Raskin and Senator Whitehouse's Get Foreign Money Out of U.S. Elections Act would close this campaign finance loophole by prohibiting U.S. corporations who have substantial foreign investors from donating to U.S. elections. We urge Congress to pass this bill swiftly and close off this vector for potential corruption and authoritarian influence.”
